General Terms and Conditions:

1. The promotion of the General Insurance Plans (as defined in Clause 13 below) (the "Promotion") runs from 1 July 2021 to 31 December 2021 ("Promotion Period").
2. The Promotion is only applicable to customers applying through DBS Bank (Hong Kong) Limited 星展銀行 (香港) 有限公司 (the "Bank") ("Customers").

5. - b. After making the Transaction, Cardholder must login DBS Card+ app and click the InstaRedeem icon to redeem the Card+ Offer. DBS\$/ COMPASS Dollar is not required to redeem for the offer. Cardholder must complete their Reward redemption within 3 months upon receiving the Reward on Cardholder's DBS Card+ app, otherwise the Reward will be forfeited without further notice.
 - d. The Reward cannot be transferred, or exchanged for cash, credit limit or other discount, good or service.
