Member Loyalty Program Terms and Conditions

- "Member" refers to users who have successfully registered as member and activated the membership account on MSIG Insurance (Hong Kong) Limited ("MSIG") website or mobile application.
- 2. "MSIG\$" refers to points awarded to members after successful insurance plan application through MSIG website or mobile application, or through promotions.
- "Loyalty Program" refers to the Members Loyalty Program operated by MSIG effective from 6 December 2018 15:00. Members can redeem gifts ("Rewards") with the MSIG\$ earned.
- 4. MSIG\$ earning from policy renewal is effective from 28 Oct 2020 00:00.

Earning MSIG\$

- 5. Welcome Offer
 - a. All new Members are eligible for a welcome offer of MSIG\$200 ("Welcome Offer"), which will be credited into Members' account automatically. Member is not required to apply any insurance plan to be eligible for the Welcome Offer.
 - b. Customer registered as new Member at online policy renewal procedure will be eligible for MSIG\$400 which will be credited to Members' account automatically.
 - c. Each new Member can only receive Welcome Offer once.
- 6. Earning through application / renewal of insurance plan
 - a. Member will be eligible for One (1) MSIG\$ for every HK\$1 net premium spent (after discount) **if all of the following conditions are fulfilled** ("Eligible Member"):
 - successfully enrolled / renewed any MSIG insurance policy made via MSIG website or mobile application while logged in as Member or registered as Member during policy application or renewal;
 - Policy enrolment / renewal is completed while logged in as Member or membership registration is completed during policy enrolment / renewal; and
 - iii. did not choose the Asia Miles offer during application.
 - b. Any decimal place in the net premium will not be included in the calculation of MSIG\$. The eligibility for MSIG\$ may be different subject to different promotions.
 - c. For new policy enrolment, MSIG\$ will be automatically credited to Eligible Member's account 14 days after the issuance of the policy document. For policy renewal, MSIG\$ will be automatically credited to Eligible Member's account within 6 to 8 weeks upon the month of successful renewal.

- 7. Members-Get-Members Referral Program ("Referral Program")

 - b. "Referrer" refers to Member who own a unique referral link in the mobile application (the "Referral Link").

- e. The Referee who successfully registered as member through the Referral Link shall be eligible for a HK\$100 premium discount eCoupon ("Discount eCoupon").
- f. The Discount eCoupon can only be used to purchase first-year premium of insurance plan.
- g. The Discount eCoupon will only be issued once to the Referee. The Discount eCoupon is non-refundable, non-exchangeable and non-returnable.

Reward Redemption

- 8. Member may use MSIG\$ before the expiry date to redeem Rewards through mobile application only. Redeemed MSIG\$ will be automatically deducted from the account immediately. Deducted MSIG\$ cannot be reissued.
- 9. Redemption of Rewards is subject to Member having adequate MSIG\$ and is subject to stock availability.
- 10. MSIG reserves the right to change the required MSIG\$ for redeeming Rewards at any time. Redeemable Rewards are as follow:
 - a. eVoucher
 - Redeemed eVoucher will be automatically saved into "My Rewards". <u>The</u> <u>effective period is 30 days following the redemption date.</u> Expired eVoucher will be invalid.
 - When Member confirms the use of eVoucher on the mobile application, system will generate a unique QR code and trigger a countdown timer. Member must use the eVoucher to redeem Rewards within the stipulated time.
 - iii. Once the redemption has been completed or the eVoucher is not used within the stipulated time, the eVoucher will be invalid and cannot be reused or reissued.
 - iv. MSIG is not the supplier for eVoucher. The use and redemption of eVoucher is subject to the terms and conditions imposed by the relevant supplier.  - b. Asia Miles
 - i. A valid Asia Miles membership number must be provided at the time of conversion. The submitted Asia Miles membership number must belong to the Member and cannot be changed after conversion.
 - ii. Converted Asia Miles will be credited to the Member's designated Asia Miles account 6 to 8 weeks upon the month of successful conversion.
 - iii. MSIG is not the supplier of Asia Miles. The use and earning of Asia Miles are subject to the terms and conditions imposed by the Asia Miles Limited ("AML"). For details, please refer to www.asiamiles.com. Any enquiry or complaint regarding the Asia Miles, the goods redeemed by/ service relating thereto should be directed to the AML. MSIG assume no responsibility / liability in respect thereof.
 - iv. Asia Miles are not transferrable, returnable and cannot be altered or redeemed for cash under any circumstances. Terms and conditions apply.

- c. MSIG Cash eCoupon
 - i. Redeemed MSIG Cash eCoupon ("Cash eCoupon") will be automatically stored in Member's "MSIG Reward (eCoupon)". The effective period is 180 days from the redemption date. Expired Cash eCoupon will be invalid.
 - ii. The premium discount of Cash eCoupon is only applicable to the first year premium of the policy.
 - iii. The Cash eCoupon is non-refundable, non-exchangeable and nonreturnable. The Cash eCoupon will not be reissued if the Member cancelled the relevant policy.
- 11. The validity period of MSIG\$ is 12 months from the issue date of the policy. Validity of MSIG\$ in the Member's account will be updated upon online enrolment of policy with MSIG\$ earning. Expired MSIG\$ will be forfeited and cannot be reissued.
- 12. The MSIG\$ records of MSIG shall prevail. Member is able to view their accumulated MSIG\$ balance online by logging into the account on website or mobile application.
- 13. MSIG\$ is non-refundable, non-exchangeable and non-returnable.
- 14. MSIG\$ reserves the right to withhold accumulated MSIG\$ if MSIG suspects there is purposively or intentionally fraud. In cases of disputes, the decision of MSIG shall be final and conclusive.
- 15. MSIG\$ is not responsible for any loss of MSIG\$ due to technological or system problems.
- 16. MSIG reserves the right to change the Terms and Condition of the Loyalty Program without prior notice.
- 17. All matters or disputes in relation to the interpretation of the Terms and Conditions shall be subject to the decision of MSIG which shall be final and binding.
